Sheriff Kendall shared the Sheriff's Office (Office) has noticed an increase of break-ins into vacation homes but believes the break-ins will decrease in the next few months. Lastly, the Office is looking to expand its partnership with mental health workers to the coastal area of the County and is actively recruiting for corrections deputies, dispatchers, and deputies. March 18th is postponed due to weather issues and will be rescheduled for April. Second, the District has submitted the application of Bill Jarusz to the County to replace Bob Kieffer on the Board of Trustees.

d. Shanél Valley Academy: *General updates from Amy Frost*

Amy shared that the Shanél Valley Academy (SVA) is currently trying to expand to provide grades 7 and 8 and is separately working to open a preschool for three- and four-year-olds. The 7th and 8th grade expansion requires approval by the Ukiah Unified School District (UUSD). A public hearing was held by the UUSD Board of Trustees (Board) on March 9th and the Board will take a vote on the proposal in April. Amy shared that the SVA would appreciate letters of support from the community from those interested in supporting their efforts. Additionally, in May, the SVA will be hosting a Cinco de Mayo Festival during which they will be inviting the public to visit the school. This Festival will be a fundraiser for the school.

e. Hopland Public Utility District: *General updates*

Julie shared that the Hopland Public Utility District (PUD) holds its monthly meeting on Zoom on the second Tuesday of each month, the week before the Hopland MAC meetings. She was unable to attend the March meeting and asked Supervisor McGourty if he has other ideas for engaging with the Hopland PUD.

f. Board of Supervisors: *General updates*

Supervisor McGourty shared that the Board of Supervisors (BOS) is trying to reorganize the Mendocino County Cannabis Department in the hopes that additional cultivators will be able to obtain permits. This includes putting applicants that have not kept-up on taxes but have continued through the application process on a time plan to keep them moving forward. The BOS is also continuing to work with local agencies on the water district consolidation process. This involves the City of Ukiah, Willow County Water District (WCWD), which services the Hopland PUD, and Millview County Water District (MCWD).

5. Discussion and possible action on Sonoma Clean Power Presentation on Climate Change Initiatives

Presentation by Felicia Smith, Sonoma Clean Power Program Manager

Felicia shared a presentation on the purpose, function, and current initiatives of Sonoma Clean Power (SCP). The SCP's primary focus is to help Mendocino and Sonoma County residents and businesses switch from fossil fuels to electric power. The SCP services all electric customers living in Mendocino and Sonoma Counties, except people living in the cities of Ukiah and Healdsburg, which have their own municipal power programs. SCP buys clean energy that is delivered to users on PG&E's transmission system. Monthly bills are sent by PG&E and include a fee for SCP to pay for electric generation and PG&E for electric delivery. SCP is a default service provider, with users having the option to opt out (and instead receive electric generation sources from PG&E). When service is established through PG&E, service with SCP starts automatically. SCP is funded through revenue, not tax dollars and also provides offers and incentives. SCP is run by its Chief Executive Officer and a small staff and is governed by the Board of Directors of the Sonoma Clean Power Authority, a joint powers authority of the member counties and cities that have voted to join. Board is advised by a public Community Advisory Committee. In response to a question, Felicia shared that for this year and next, the SCP rates are roughly 5% lower than PG&E's.

Felicia additionally shared information on current SCP incentives for heat pump heating and cooling systems and water heaters. Additionally, she shared information on the federally funded Local Income Home Energy Assistance Program that is locally managed by North Coast Energy Services in Ukiah. She can share additional information with anyone interested to learn more.

6. Discussion and possible action on Mendocino County Museum

Presentation by Karen Mattson, Mendocino County Museum Administrator

Karen Mattson provided the following information prior to the meeting. The next Mendocino County Museum Community Forum will be held at the Ukiah Branch Library on Tuesday, April 4th. The Museum greatly values feedback from the community and would like to connect to envision a bright future for the Museum. There will be additional meetings in Fort Bragg, Point Arena, and Round Valley throughout the month of April.

The community is also invited to participate in the Museum's survey, the QR code is available on a flyer that Karen shared and is accessible on-line (on the Museum webpage on the Mendocino County website) and in-person at the Museum. Data collected will help the Museum create a 5-year strategic plan.

Karen also shared that a new exhibit, Gadgets Galore, will open April 1st and will be filled with hands-on activities.
